To all SOGHU registered collectors,

Thanks to a management approach fuelled by good judgement and a commitment to efficiency, along with the hands-on involvement of collectors on the field, the Société de gestion des huiles usagées (SOGHU) is pleased to announce a re-evaluation of the incentive amounts granted to collectors for used oil and antifreeze containers.

The agreement between the collectors and SOGHU requires a delay of 90 days between the notice to collectors and entry into force of such a motion, we believe that you would accept that this motion comes into force on April 1st, 2019.

The motion adopted by SOGHU board members during their meeting on December 7th 2019 provides for an increase in subsidies paid to collectors for used oil and antifreeze containers .

We ask that you add the attached updated Appendix I to the signed copy of your Collectors' Agreement.

Also attached to the current email is the ***Increase in return incentives effective April 1st 2019*** on which you will find «**Table A**» which displays subsidies currently in effect for all your collections completed prior to April 1st, 2019, as well as «**Table B**» which displayed subsidies effective on all collections completed on or after April 1st 2019.

*******IMPORTANT NOTICE*******

For collectors who still make their incentive claims in paper format, please take note that you will find on our website, a claim form for your collections (pick ups) prior to April 1st 2019 and a form for your collections (pick ups) from April 1st and forward for each product concerned by the increase in subsidies.

It is very important to do your incentive claims using the form corresponding to the date of your collections (pick ups).
